Vendors shall submit their application and will receive conformation once the application has been processed and accepted by the Planning Committee. Vendor space preferences will be considered on a first-come first-served basis: however, space allocation will be selected by the committee and will be final.

General Rules

- All vendors must supply their own canopy if needed. Canopy cannot be oversized to the space provided. Please rent additional spaces if required. Vendor spaces are 10 feet by 10 feet. No booth sharing allowed.
- This is a family event. No flammable or harmful items may be displayed.
- Vendors are responsible for cleanup. Vendors are responsible for removing all trash from their area. This is a pack in pack out event.

Hold Harmless Clause
